#### The Role

As Programme Manager for Youth & Ambition, the successful candidate will be responsible for managing two high-impact strategic programmes; Generation Innovation and Stryve (pilot programme). Both programmes are centred around informing, upskilling and empowering young people to recognise their potential and thrive as leaders, innovators and entrepreneurs. With Catalyst vision, 'Opportunity for all from world leading innovation', a commitment to promoting diversity and equal opportunities for young people is crucial for this role.

**Generation Innovation** energises the imaginations and aspirations of young people in Northern Ireland by developing a foundational, Design Thinking skillset for their future careers. The programme empowers students through 3 unique offerings: high-energy workshops, 'Impact Day' design sprints, and a core Work Experience Programme for 17–18–year–olds.

**Stryve**, in conjunction with Rio Ferdinand Foundation and funded by International Fund for Ireland (IFI), is an innovative pilot project aiming to remove barriers to employment for young people furthest from opportunity. This youth development programme will provide young people with accredited training in foundational skills, upskill in Innovation and Entrepreneurship, develop creative thinking to turn ideas to reality, access to industry mentors, work experience and further development opportunities.

- 3. To maintain strong working relationships with Project Partners, external stakeholders including youth organisations, public sector, Catalyst community members, and Partner organisations.
- 4. Recruit programme participants, quality speakers, panellists, and volunteers to achieve targets.
- 5. Provide ongoing support and advice to participants.
- 6. Lead and line manage a small team of direct reports.
- 7. Ensure feedback and impact data is collated and presented in a clear and timely manner.
- 8. Set and manage budgets for each programme and specific events.
- 9. To prepare and deliver visually appealing keynote presentations to a range of audiences as required.
- 10. Support development of funding applications and relationships for the longterm sustainability of the programmes.

- 11. Work closely and report regularly to both the GI Programme funders, GI Steering team and IFI Project Funders to ensure compliance with programme guidelines.
- 12. Working closely with Catalyst brand and marketing team to clearly articulate programme messaging to targeted audiences.
- 13. Ensure data protection and safeguarding processes are up to date and stringently adhered to.
- 14. Management of 3<sup>rd</sup> party suppliers.
